For the purpose of a thorough restoration, I am researching a beautifully crafted sandstone horse watering fountain in Port Hope Ontario. Part of the carving on the fountain is a plaque that reads: "erected by mayor Craig - 1878". The fountain stands about 8 feet tall and has in living memory always stood on the lawn behind the town hall in Port Hope. For its restoration, we have dismantled it and have discovered the name H. Lithgow carved on the underside of one of the top slabs. Above this slab, there was a spherical ball of sandstone which is now missing. Along with the name, we can see his trade mark which consists of three overlapping equally sized equilateral triangles.

We have one c. 1880 photo which shows the fountain/water trough in its present location, but which also indicates some significant alterations to its base.
Does anyone know anything about our "H.Lithgow"? Does anyone have any historic photos of our fountain? I'd be glad to send some current photos to anyone who is interested in our project.
